This is not an employment application. The purpose of this form is to assist in the creation of a safe environment for children, students and vulnerable adults who participate in the programs of Faith Community Church or use church facilities.

This Application and other forms associated with safety clearance will be kept in a locked file cabinet accessible only by the Safety Committee, Pastors, Elders or those directed by the aforementioned to perform certain administrative tasks. You are encouraged to ask questions of any Pastor or Elder about confidentiality if you have any reservations.

Summary of the Child Safety Process

- 1. You receive this Safety Application form
- 2. Return this form in a sealed envelope marked "Safety Application For Volunteers" to a Pastor, the Youth Director, the Children's Ministry Director, or the Church Office. After the Safety Committee reviews your application, you'll complete the following available at faithcc.info/service-opportunities
 - a. Children's Ministry Policy or the Student's Ministry Policy (depending on your interest)
 - b. Instructions to perform 3 background checks available on our website: PA State Police Criminal Record, PA Child Abuse History Clearance, FBI Fingerprint or Affidavit (if PA resident for 10+ years)
- 3. After you complete the Background Checks and read the policy manual please schedule an informal interview with either the Youth Director or the Children's Director (depending upon your interest). When you come to the interview please bring the following...
 - a. Policies & Procedures Statement of Acknowledgement & Agreement (back page of either Policy Manual)
 - b. Official Printed Results of 3 Background Checks
- 4. Finally, you'll be asked to read and sign the FCC Code of Conduct form.
